

01-01 ADVERTISEMENT (NOTICE TO BIDDERS)

The Westmoreland County Airport Authority will receive proposals for Contract No.121, at the Arnold Palmer Regional Airport, 148 Aviation Lane, Suite 103, Latrobe, PA 15650 until 11:00 AM local time on June 7, 2017 which proposals will immediately thereafter be publicly opened and read aloud.

CONTRACT NO. 121 TERMINAL ACCESS ROAD

The drawings, specifications, and other contract documents are on file and open to the public for inspection at the office of the Engineer, GAI Consultants, Inc., 203 West Weber Avenue, DuBois, PA, 15801. Contract documents, proposal forms, and drawings may be obtained from GAI Consultants, Inc. upon payment of \$100.00 for each set of bidding documents. Payments are non-refundable.

Bids shall be on the prescribed forms furnished by the Westmoreland County Airport Authority and shall be in accordance with the General Provisions, Proposal Requirements and Conditions Section 20. The Westmoreland County Airport Authority expressly reserves the right to accept or reject any or all bids or to waive informalities in the same. Each bidder must deposit with this proposal a guarantee in an amount equal to at least ten percent (10%) of his bid. The "Bid Guarantee" shall consist of a firm commitment such as a bid bond, certified check, or other negotiable instrument accompanying a bid as assurance that the bidder will, upon acceptance of his bid, execute such contractual documents as may be required within the time specified. No bidder may withdraw his bid within ninety (90) days after the actual date of the opening thereof.

Work shall be commenced within ten (10) days of the date specified in the written notification to proceed and shall be fully and finally completed within one hundred twenty (120) calendar days of the date specified in the written notification to proceed.

The Westmoreland County Airport Authority hereby notifies that it will affirmatively ensure compliance with the regulations relative to nondiscrimination in Federally assisted programs of the Department of Transportation, title 49, Code of Federal Regulations, Part 26 (as they may be amended from time to time).

The contractor or subcontractor, by submission of an offer and/or execution of a contract, certifies that it:

- a) is not owned or controlled by one or more citizens or nationals of a foreign country included in the list of countries that discriminate against U.S. firms published by the Office of the United States Trade Representative (USTR);
- b) has not knowingly entered into any contract or subcontract for this project with a contractor that is a citizen or national of a foreign country on said list, or is owned or controlled directly or indirectly by one or more citizens or nationals of a foreign country on said list;
- c) has not procured any product not subcontracted for the supply of any product for use on the project that is produced in a foreign country on said list.

All bidders must comply with the Antidiscriminatory Act and shall sign an affidavit as contained in the specifications.

Successful bidder must enter into the Agreement and furnish a Contract bond and evidence of required insurance within fifteen (15) days after the notification of acceptance of such proposal, all as more specifically required in the Contract Documents.

Wages as predetermined by the PA Department of Labor and Industry included in specifications and contract documents and/or addenda thereto shall be used by the contractor in paying labor in connection with the work under this contract.

All work under this contract shall be under and subject to the regulations contained in Section R of the Contract Documents.
